CLARIFICATION MEETING

Clarification Meeting was held on July 29th, 2013 and commenced at 10:00 A.M. in the premises of the Municipality Zemunik Donji. The main purpose of this meeting was explaining tenderers all unclear details and issues related to the project, as well as answering their questions.

Ivica Šarić, Municipality Mayor welcomed all participants and introduced the scope of works covered by this contract. He informed the participants that the Municipality of Zemunik Donji has submitted an application for funds from the IPARD program for the development of rural infrastructure. Furthermore, Mr. Šarić pointed out that the public procurement is conducted by special procedure which is proscribed by the European Union and Practical guide to Contract Procedures for EU External Actions (PRAG). It was also highlighted at the meeting that all requirements for participation in the Tender are given in the Tender Dossier

Mr. Mate Jurčević, representative of the consulting company Moneo Ltd explained that the language of tendering procedure is English and that all written communication for this tender procedure must be in English.

Mrs. Jagoda Slipčević, as general designer of the project, explained the technical details about the project.

Municipality Mayor, Mr. Ivan Šarić terminated the clarification meeting and emphasized to the tenderers that all questions asked at the meeting, as well as other potential questions, have to be delivered to the Municipality of Zemunik Donji in written format. In conclusion, Mr. Šarić also stated that all of the questions asked at meeting will be answered in written format as well.

The Clarification meeting terminated at 11:00 A.M.
